





Sub: Re-constitution of Anti-Ragging Squad (ARS)-Order

In accordance with the notification by the All India Council for Technical Education (AICTE) vide F.no 37-3/Legal/AICTE/2009, Regulation No.6 (C), it is mandatory to constitute an Anti-Ragging Squad (ARS) is addition to the anti-Ragging Committee (ARC).

The responsibilities of the Anti-Ragging Squad are given below

- a) To maintain vigil in the Campus, carry out surprise raids on hostels and other places vulnerable to incidents and having the potential for ragging.
- b) To carryout patrolling and remain mobile, alert and active at all times.
- c) To conduct an on-the-spot enquiry into any incidents of ragging referred to it by the Head of the Institution or any member of the faculty or any member of the Staff or any student or any parent or guardian or any employee of a service provider or by any other person, as the case
- d) To submit the enquiry report along with recommendations to ARC for action.
- e) To conduct such enquiry observing a fair and transparent procedure and the principles of natural justice and after giving adequate opportunity to the student or students accused of ragging and other witness to place before it the facts, documents and views concerning the incidents if ragging and considerations for such other relevant information as may be required.
